## **AROUND THE GLOBE**

#### ANDHRA PRADESH GOVERNMENT'S BORROWINGS FOR FIRST HALF OF 2020-21 FISCAL FAR EXCEEDED REVENUES

deficit he touched revenue a 45,472.77 Rs staggering crore, state according to the finance accounts released by the Comptroller and Auditor General. It said the state borrowed Rs 55,169.84 crore from different sources in the first six months as against Rs 48,295.59 crore target entire fiscal.The revenue for the accruals, on the other hand, were just 27.73 per cent at Rs 44,915.52 crore in the first half out of the targeted Rs 1,61,958.50 crore for the year.

#### LENDING INSTITUTIONS TO GIVE CASHBACK AFTER GOVERNMENT ANNOUNCES WAIVER OF INTEREST

The government waived interest on interest for loans up to Rs 2 crore irrespective of whether moratorium was availed or not. The Department of Financial Services came out with operational guidelines in the backdrop of Court's direction to the Supreme implement the interest waiver scheme, which is likely to cost the exchequer Rs 6,500 crore.The scheme can be availed by borrowers in specified loan accounts for a period from March 1 to August 31, 2020.

#### FINANCIAL CONDITIONS IN INDIA HAVE RECOVERED SIGNIFICANTLY AFTER HITTING THE ABYSS IN APRIL: CRISIL

CRISIL launched financial a new conditions index showing India's financial conditions have eased and are the best seen in two years, oweing to RBI's sharp rate cuts & unconventional measures . But some pockets still have tighter conditions than their long-term averages, particularly credit growth, higher corporate bond spreads over G-Secs, which could delay transmission of policy rates. Crisil's financial condition index which turned negative since the crisis at IL&FS has started improving. Crisil chose to launch this index because with the pandemic resulting in one of the biggest recessions, the functioning of the financial sector becomes critical - not only for its role of supporting borrowers, but also for policy implementation.

#### INDIA'S APRIL-SEPT FISCAL DEFICIT AT RS 9.1 LAKH CRORE

India's fiscal deficit stood at Rs 9.1 lakh crore halfway through this financial year, exceeding the full-year target of Rs 7.96 lakh crore by almost 15%, according to official data released.With the government already having increased its market borrowing target for the year to Rs 12 lakh crore from Rs 7.8 lakh crore stated in the budget, the indications are that it will breach the fiscal deficit target of 3.5% of GDP.

## **INCOME TAX**

## FINANCE MINISTRY EXTENDS DUE DATE FOR FURNISHING OF INCOME TAX RETURNS AND AUDIT REPORTS FOR AY 2020-21:

- The due date for submission of various forms of audit report under income tax act for the taxpayers, for whom prior due date was 31st October, 2020,has been extended up to 31st December, 2020.
- The due date for furnishing of Income Tax Returns for the taxpayers who are required to get their accounts audited ,(including their partners)and who are required to furnish report in respect of international/specified domestic transactions has been extended from 30th November, 2020 to 31st January, 2021.
- The due date for furnishing of Income Tax Returns for the other taxpayers stands postponed to 31st December, 2020.

CBDT notifies variation limits for Transfer Pricing u/s 92C to be 1% in case of wholesale trading and 3% in case of others.

CBDT prescribed the Income Tax Authority for Survey u/s 133A superseding the order dated 18.09.2020.

ICAI issues checklist for Tax Audit under Section 44AB.

CBDT amends IT Rules for provisions related to Sec. 115BA, 115BAA, 115BAB, etc. for depreciation , Form 3CD(Tax Audit), Form 3CE and new forms for related options is inserted.

> CG has extended the date for payment without additional amount under Vivad se Vishwas(VSV) from 31.12.2020 to 31.03.2021.

## **CORPORATE LAWS**

## RELAXATION FROM THE RESIDENCY REQUIREMENT OF 182 DAYS IN A YEAR IN VIEW OF COVID-19 OUTBREAK:

MCA clarifies that non-compliance of minimum residency in India for a period of at least 182 days in a year, by at least one director in every Company, under Section 149 of Companies Act, 2013 shall not be treated as non-compliance for the financial year 2020-2021 also.

## MCA RELAXES THE PROVISIONS OF ALLOTMENT TO QIB

MCA amends Companies (prospectus and allotment of securities) amendment Rules 2020, henceforth, one Previous Special resolution passed per year shall be sufficient for all the allotments of any securities to Qualified Institutional buyers (QIB) during the year .

## THE NUMBER OF HSN DIGITS REQUIRED ON TAX INVOICE

With effect from the 01st day of April, 2021 as per CGST rule 2017 read with Integrated Tax shall every Registered person shall mention the required number of HSN digits while producing the invoice:

S.No	Aggregate Turnover in the preceding F.Y.	Number of Digits of Harmonised System of Nomenclature Code (HSN Code)
1.	Up to rupees five crores	4 digits
2.	more than rupees five crores	6 digits

### SPECIAL PROCEDURE FOR TAXPAYERS FOR ISSUANCE OF E-INVOICES DURING OCTOBER 2020

A Registered person preparing any tax invoice during the period of 1st to 31st October 2020 is required to follow the special procedure- the said persons shall obtain an Invoice Reference Number (IRN) for such invoice by uploading specified particulars in Form GST INV-01 on the GST Portal with in 30 days from such invoice date ,failing to comply with same shall tantamount to the same being not treated as invoice
